

FUND OBJECTIVE & INVESTMENT POLICY

The Fund aims to deliver medium to long-term capital growth over time. The Fund invests in a diversified range of equities, preference shares, bonds, debentures, money market, fixed income, property markets and instruments based on the value of any precious metal. The equity allocation will be managed at a maximum effective exposure, including offshore equity, up to 75%. The Fund is permitted to invest in listed and unlisted financial instruments in line with the conditions as determined by legislation from time to time. The Fund will predominately invest in South African markets but is however permitted to include investments in offshore jurisdictions subject to the investment conditions determined by legislation from time to time. The Fund complies with Regulation 28 of the Pension Funds Act.

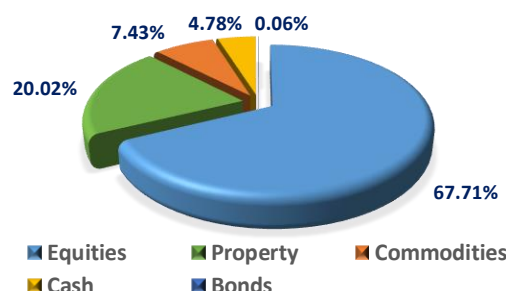

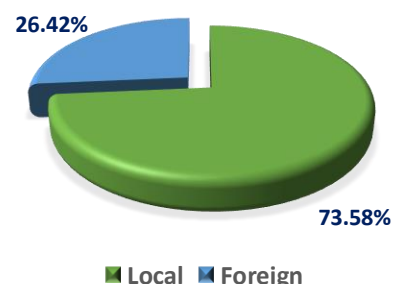

Investment Management Commentary

For the month of January, the Fund returned 4.03% relative to its benchmark of 3.98% with the rand depreciating by 3.17% against the US dollar. The Fund remains one of the top-performing local balanced funds over a rolling one-year period (as per ASISA's Multi Asset High Equity classification).

January was a fantastic month for equity markets. A clear risk-on environment paired with a weak dollar buoyed emerging markets, with the MSCI Emerging Markets Index up 2.93% and the JSE All Share Index increasing by 5.16%. A driver of this JSE outperformance was strong gains for both Naspers and Prosus, who combined now make up more than 20% of the index. The Fund benefitted from this bump with both Prosus and Naspers being major constituents. Moving forward we will remain invested in both companies as we think the potential for unlocking value through the reduction of their discounts to NAV provides a compelling narrative.

Alibaba was the best performing foreign equity holding during the month as it benefited from a broad recovery in Chinese technology companies, as well as from excitement surrounding a public appearance from their co-founder and executive chairman, Jack Ma. There had been speculation from market participants as to his whereabouts after a prolonged period removed from the public eye. The stock was up 6% during the month.

The biggest news of the month for local markets was the announcement of the vaccine rollout in South Africa. President Ramaphosa's rollout plan has largely been met by a skeptical South African media, who question the government's ability to deliver on what is a tremendously difficult logistical task. This, combined with concerns surrounding the efficacy of vaccines to the South African strain, means that the country looks a long distance away from being able to return to some degree of normality.

The uncertain state of the pandemic is going to make the preparation of the fiscal budget due to be delivered in February even more difficult. Tito Mboweni needs to desperately fund a vaccine program and uplift the real economy; this may prove to be a difficult task given the country's strained balance sheet. Thus, the focus of the speech will inevitably be on the Finance Minister's ability to fund relief measures without burdening citizens with aggressive tax hikes. On the cards is an introduction of a potential wealth tax – a topic which makes several economists shudder.

South African specific risks are plain for all to see, and despite strong performance from local companies in the month of January, we remain confident in our strategy, with our Fund being more than 90% rand-hedged going into February.
